Sub: Homi Bhabha National Institute (Deemed University), Mumbai - Recognition of M.Ch (Plastic & Reconstructive Surgery) qualification for 2 seats in respect of students being trained at Tata Memorial Hospital, Mumbai.

Sir/ Madam,

I am to state that the General Body of this Council at its meeting held on 22/11/2016 considered the Council Assessor's Report (27th June, 2016) on the physical and other teaching facilities available at Tata Memorial Hospital, Mumbai for the award of M.Ch (Plastic & Reconstructive Surgery) qualification for 2 seats under Homi Bhabha National Institute (Deemed University), Mumbai. The Council approved the following recommendations of the Postgraduate Medical Education Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Council Assessor's Report (27th June, 2016) and decided to recommend to the Central Government that M.Ch (Plastic & Reconstructive Surgery) qualification for 02 seats granted by Homi Bhabha National Institute (Deemed University), Mumbai in respect of students being trained at Tata Memorial Hospital, Mumbai be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

You are therefore requested to notify the above qualification at the earliest.
