- 5. **a)** The SR post is of 1 year duration commencing from 1<sup>st</sup> August, 2015. Selected candidates has to deposit an amount of Rs.60,000/- at the time of joining or the same will be deducted in Six equal installments from their salary. The deposit will be refunded without interest on the completion of six months term with one months' notice or after completion of Senior Resident training / term whichever is later. However, Resident can leave the post after completing six months term with one month's notice and in such case the deposit will be refunded. If Resident leave the post midway, without notice his/her last month's pay (30 days) will be forfeited.
