<b>Course Name &amp; Course Description</b>	<p><b>“TMC FELLOWSHIP IN SPEECH AND SWALLOWING THERAPY IN DEPARTMENT OF HEAD &amp; NECK ONCOLOGY” Commencing from 02.01.2023 at Tata Memorial Hospital.</b></p> <p>Tata Memorial Centre, Mumbai announces its 4<sup>th</sup> batch One Year Advanced <b>“Speech and Swallowing Therapy Fellowship Program”</b>. The eligibility criteria is explained below:</p> <p>This fellowship is an unique program in India, gets an opportunity to learn Head &amp; Neck Cancer rehabilitation in depth along with hands on clinical skills such as learning and Mastering in clinical, endoscopy and Fluoroscopic swallowing studies, Total larygectomy rehabilitation – focus on Tracheo – Esophageal Puncture Voice Protheses and its candidacy, other alaryngeal voice rehabilitation will be provided, voice evaluation and therapy also focuses on rehabilitation following thoracic surgeries such as post esophagectomy and lobectomy functional rehabilitation, post neurosurgical speech and swallowing rehabilitation too. Fellowship will have focus on close working in multidisciplinary team such as head neck surgical Oncologists, radiation and medical oncologist, jointly perform video fluoroscopy with radiology team, Speech therapy led endoscopy services for Functional assessment and therapy. It is a one year intensive program, facilitate to learn and perform advanced speech therapy practice for speech and swallowing rehabilitation in cancer care. Interested speech-language therapists can apply for it.</p>

**The candidates shall make a online payment of. Rs. 250/- as application fee on or before 28.11.2022.** No other mode of payment will be accepted. Female, SC / ST and physically handicapped candidates are exempted from paying of application fee while submitting application.

For applying Online, the applicant must possess valid email ID. All correspondence with the applicant will be done through registered email only. During the period of fellowship, the Trainee shall not apply for any post or any other courses/ P.G. studies / Scholarship or appear for any examination or interview outside.

Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates, as may be fixed by the hospital. Those candidates who are found below expected standards with consistent poor performance in studies will be terminated from the training course.

Persons working under Central/State Government/Autonomous Body/Semi Government Organizations and other Public Sector Undertakings must submit their application forwarded through the head of the organization.
