- 5. Time and date of opening of Part II- Commercial Bid will be intimated only to the tenderers who will be qualified after evaluation of Part I- (Technical Bid) i.e., Part II of the tenders will be opened on a date to be intimated later, only if Part I of the bid is technically accepted. 10. OPENING OF BIDS

12. TENDER EVALUATION CRITERIA

- a. The evaluation will be a two-stage process: 1. Technical Evaluation 2. Commercial Evaluation.

- c. Price Bids will be opened only for Techno-Commercially accepted bidders.
- d. The contractor shall be awarded the work on an overall L-1 basis for the full scope of the tender.
- e. In case of a tie between two or more than two bidders for L1 price. Bids shall be called for a discount on the price offered in sealed envelopes from all the L1 bidders.
- f. The Price bid shall be evaluated on an overall basis.

13. TENURE OF THE CONTRACT

The CAMC contract will be valid for 1 year with effect from the date of award of the contract with terms & conditions. However, the final decision shall rest with the Department only.

18. AWARD OF CONTRACT/PURCHASE ORDER

The Purchaser will award the contract/purchase order to the bidder whose quotation has been determined to be substantially responsive and who has bided the lowest evaluated quotation price.

- a. Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and cancel the bidding process, and reject all quotations at any time prior to the award of the contract.
- b. The bidder whose bid is accepted will be notified of the award of the contract by the Purchaser prior to the expiration of the bid validity period. The terms of the accepted bid shall be incorporated into the purchase order/work order.
- 19. Rates should be quoted inclusive of packing, forwarding, postage and transportation charges, etc.
- 20. The bidder will be responsible for the safe transit of the goods under proper goods insurance coverage and under standard conditions & The risk of loss in transit of the goods/services shall be the responsibility of the bidder.
- 21. The competent authority reserves all rights to reject the goods if the same is not found in accordance with the required description/specifications/quality.
- 22. If the Vendor Capability Proforma provided and the documents required as mentioned are not submitted, MPMMCC/HBCH reserves the right not to accept the offer.
- 23. The Director, MPMMCC/HBCH reserves the right to cancel, adding, reducing, or deferring the purchase without assigning any reason thereof, and a claim on this behalf in any way shall not be tenable for compensation in one way or the other. B. SCOPE OF WORK

The firm will have to ensure the following terms & conditions to keep the Hardware and Operating System of the Servers & other items in good working order:

- 1. This CAMC covers all hardware, software, its licenses of OEM if any, with back-to-back OEM Support.
- 2. Please note that you have to carry out 4 no's Preventive Maintenance at an interval of 3 months each year and have to fixup the PM Schedule with user dept. well in advance.
- 3. In case of breakdown calls, the same should be attended immediately.
- 4. All spares of CAMC are to be entered through challan at the entrance at Security.
- 5. In case of replacement of spares, defective spares parts are the property of vendor & the defective parts need to be taken back by CAMC vendor immediately against the delivery challan of new spare parts OR Non-Returnable Gate Pass.
- 6. In case of any storage device, wiping/degaussing of disk data must be ensured before handing over to OEM for replacement. The standard practices must be followed for wiping/degaussing of disk to ensure the data security and an undertaking must be submitted by OEM to prevent the misuse of data if any.
- 7. The CAMC of software covers troubleshooting and resolution of issues arises with any of supplied software/utilities with IBM machine. It will also cover the patch updates, software upgradation, fixing of known vulnerabilities if any.
- 8. All equipment which are supplied at the point of sale will be part of contract and consumables like UPS batteries are exclusive of CMC.
- 9. No any other payment will be made for your engineers visit on site in case of major issue resolution if any.
- 10. The AMC will be comprehensive and the cost of spare if required during the maintenance period will be included. Un- serviceable parts should be replaced at no extra cost. In case of replacement of the part, the defective part is removed from the system and will be the property of the firm.
- 11. The firm will be responsible to provide OS (Operating System), reloading of OS with all the drivers, and OS/firmware upgrades. Device drivers, system configuration, and network configuration on the servers during the period of maintenance.
- 12. The firm will be responsible to provide 97% uptime for systems and failing which a penalty, as proposed by HBCH/MPMMCC, will be imposed. However, before imposing a penalty, HBCH/MPMMCC will issue a show-cause notice in which the details of downtime will be mentioned. It will also include the penalty proposed to be imposed on the vendor.

The firm will be responsible to attend the complaint on a call basis and all the complaints/calls should be attended to by Engineer within 4 hours of logging and not more than 6 hours of logging such complaints.

C. OTHER TERMS & CONDITIONS

1. PENALTY:

- A. In cases of downtime beyond those stipulated above, the penalty will be automatically deducted from the quarterly payable amount.
- B. In case the agency fails to provide any service listed above, there would be a minimum penalty of Rs. 1000/- per day for each service affected.
- C. Penalty to be imposed will be subject to a maximum of the total value of the contract. In case of gross negligence and downtime, security deposited by the firm can be forfeited besides immediate cancellation of the contract.

2. RIGHT OF ACCEPTANCE:

HBCH/MPMMCC reserves the right to accept or reject any or all tenders/quotations without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender. HBCH/MPMMCC also reserves the right to accept all the items/equipment/instruments in the given tender or only part of it in any given schedule without assigning any reason.

3. VALIDITY OF THE BIDS:

The bids shall be valid for a period of 180 days from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid which may be extended if required.

4. RESPONSIBILITY FOR EXECUTING THE CONTRACT:

The agency is to be entirely responsible for the execution of the contract in all respects in accordance with the terms and conditions specified in the acceptance of the tender.

- A. The agency shall not sublet transfer or assign the contract or any part thereof to any third party without the written permission of The Director (MPMMCC/HBCH), Varanasi. 6. COMMUNICATION OF ACCEPTANCE:

7. INSOLVENCY ETC.:

In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other under the Insolvency Act made against them or in the case of a company passing any resolution or making of any order for winding up, whether voluntary or otherwise or in the event of the firm failing to comply with any of the conditions herein specified, HBCH /MPMMCC, Varanasi shall have the power to terminate the contract without any prior notice.

8. FORCE MAJEURE:

If at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, the act of a public enemy, civil commotion, sabotage, fire, floods, exception, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by a party to other within 21 days from the date of occurrence thereof, neither party hall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance and deliveries have been so resumed or not shall be final and conclusive.

Further, if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, HBCH / MPMMCC, Varanasi party may, at least option to terminate the contract.

11. REPEAT ORDER:

The Institute has the right to place an order with mutual acceptance of the contractor/supplier for an additional quantity equal to 100% of the original Order with the successful bidders at the same rates, terms & conditions within a period of 01 Year from the date of order or during the currency of the order.

- C) The currency of all quoted rates shall be in Indian Rupees. All payment shall be made in Indian Rupees.
