Candidates shall verify their eligibility for the post before applying and making payment of application fee.
4. Last date for online application is **11.10.2021** upto 05.30 PM. The candidate is advised to apply through online well in advance without waiting for the closing date.

Once applied online, the candidates are required to download the submitted application and email to hrdhbchrcv@gmail.com along with the relevant supporting documents pertaining to candidate's education and experience in one **pdf file**. Shortlisting of the candidate will be done on the basis of the documents submitted.
6. All correspondence with the applicant will be done through the email mentioned at para 5 only.
