- 1. **Security Deposit:-**The selected Senior Resident will have to deposit Rs. 1,27,260/- (Rupees One-Lakh Twenty Seven Thousand Two Hundred Sixty Only). The security deposit will be refunded after successful completion of tenure.
- 2. Accommodation: Accommodation will be provided on sharing-basis, subject to availability.
- 3. **Degree Recognition:** All Graduate/ Post Graduate/ Post-Doctoral degree must be recognized by National Medical Commission (erstwhile Medical Council of India).
- 4. **Candidates employed in other organizations:** The candidates who are working under Central/ State Government/ Autonomous Body/ Semi Government Organizations and other Public Sector Undertakings **must** submit their applications through the Head of their Institution.
- 5. Online application in the prescribed form must be filled out completely in all respect. Incomplete applications will be rejected. Separate application should be submitted for each post.

- 6. **Application Fee:** After successful completion of online application, General and Other Backward Class (OBC) candidates shall pay the online application fee of **Rs. 300/-** (Rupees Three Hundred Only) by using Debit Card/ Credit Card. The application fee once paid will not be refunded under any circumstances. Female candidates, candidates of Scheduled Caste and Scheduled Tribe and Persons with disabilities are **exempted** from paying application fees. Candidates shall verify their eligibility for the post before applying and making payment of application fee.
