- Degree Recognition:** All Graduate/ Post Graduate/ Post-Doctoral degree must be recognized by National Medical Commission (erstwhile Medical Council of India).
- Candidates employed in other organizations:** The candidates who are working under Central/ State Government/ Autonomous Body/ Semi Government Organizations and other Public Sector Undertakings **must** submit their applications through the Head of their Institution.
