If selected, their joining will be considered **after production of passing certificate**. Appearing candidates must submit their training completion certificate along with the application.
- Accommodation will be provided on sharing-basis, subject to availability.
- The Graduate degree/ Diploma must be recognized by Medical Council of India.**
- The candidates who are working under Central/ State Government/ Autonomous Body/ Semi Government Organizations and other Public Sector Undertakings must submit their applications through the Head of their Institution.
- Online applications in the prescribed form must be filled out completely in all respects. Incomplete applications will be rejected. - Candidates (General & OBC) shall pay the **online application fee of Rs. 300/- by using Debit Card/ Credit Card**.
