Tata Memorial Hospital (TMH) announces a Certificate Course in Onco- Occupational Therapy, Considering the ever increasing number of Cancer patients in our country to decentralize the Oncology rehabilitation and make this special rehab care available to every needy cancer patient of our community. There is strong need to produce expert Occupational Therapists to meet the rehabilitation needs of cancer patients.

This course aims at providing an in-depth knowledge in Oncology and Onco rehab to both Graduate and post graduate Occupational Therapy professionals, there by generating advanced Occupational Therapy Services specialized in Onco care for the community.

This program will be focused on training Occupational Therapists in different conditions in Oncology and Palliative care.

If trainee leaves the training at any time before completion of the training, deposit will stand forfeited.
SERVICE BOND	Selected Non Sponsored Candidates will be required to execute an agreement to serve the Tata Memorial Centre w.e.f. 01.01.2019 on a consolidated remuneration @ Rs.12,000/- p.m (Rupees Twelve Thousand Only) per month for B. O.Th candidates and Rs. 15,000/- (Rupees Fifteen Thousand Only) per month for M.O.Th candidates for a period of six months after successful completion of the training. No Bond is required for Sponsored & Internationa Candidates.

All the outstation candidates are required to make a note that Accommodation will not be provided. A Sum of Rs.2,000/- p.m. (approx) will be charged towards diet charges, for which a sum of Rs.4,000/- to be paid as a diet deposit.

The candidate make a online payment of Rs.250/-, drawn in favour of Tata Memorial Centre, Parel, Mumbai, on or before **15.06.2018** and submit the receipt copy alongwith application form to H.R.D. Department, 4th Floor Service Block Bldg, Tata Memorial Hospital, Parel, Mumbai – 400 012. No other mode of payment will be accepted. Female, SC/ST/OBC and Physically Handicapped candidates are exempted from paying of application fees while submitting application.

HOW TO APPLY: Eligible applicants would be required to apply ONLINE through the link on our website viz. http://tmc.gov.in No other mode of application will be accepted.

For applying Online, the applicant must possess valid email ID and a facility to take printout of the Acknowledgement Receipt. All correspondence with the applicant will be done through email only. Information regarding offer letters etc. will be provided through email. Responsibility of receiving, downloading and printing of related documents will be of the candidate. Tata Memorial Centre will not be responsible for any loss of email sent, due to invalid/wrong email ID provided by the candidate or delivery of emails to spam/bulk mail folder etc.

The application can only be submitted after entering the Registration Slip No., DD Number. The candidate must submit a recent passport size photograph, attested copies of all certificates regarding Date of Birth, Educational Qualifications, Experience Certificates, Caste Certificate, Physically Handicapped Certificate etc. along with the copy of online application form so as to reach the H.R.D. Dept. Service Block Bldg, 4th Floor, Tata Memorial Hospital, Dr. E. Borges Marg, Parel, Mumbai – 400 012 on or before 15.06.2018. Only committed applications will be accepted. The candidate will be responsible if the application is not committed online and submitted to H.R.D. Department.

During the period of training, the Trainee shall not apply for any post or any other courses/ P.G. studies / Scholarship or appear for any examination or interview outside.

Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates, as may be fixed by the hospital. Those candidates who are found below expected standards with consistent poor performance in studies will be terminated from the training course.

Persons working under Central/State Government/Autonomous Body/Semi Government Organizations and other Public Sector Undertakings must submit their application forwarded through the head of the organization.

Late & incomplete applications are liable to be rejected. No correspondence of any kind will be entertained. Last date for receiving applications may be relaxed by two weeks in respect of candidates working or training abroad provided they send a PDF version of the complete application with all relevant attachments before the last date.
