4. The candidates who are working under Central / State Government / Autonomous Body / Semi Government Organizations and other Public sector Undertaking must submit their applications through the Head of their Institution.
5. Online applications in the prescribed form only super-scribing the post applied for on the cover with **self-attested** copies of all certificates should be forwarded to the **Asst. The Online application forms must be filled out completely in all respects. Incomplete applications will be rejected.
