The First EQuIP India Conference QICON 2023



The first International Quality Improvement Conference - QICON 2023, was held on the 14th and 15th of March 2023, was organised and conducted by the QI Hub of the National Cancer Grid - India, at the St John's National Academy of Health Sciences, Bangalore, Karnataka. The alumni from the five EQuIP cohorts since 2017 actively participated in the event and contributed to a dynamic plan – going forward.

The conference deliberated up on three specific domains of QI development relevant to India; i) the way-forward for the standard QI training & QI Hub that envisioned enhancing the culture of QI through increased access to competency training for NCG institutions while maintaining the quality of educational outcomes, ii) Multicentric QI – Quality Improvement Collaborative (MQuIC) towards accelerating the oncology-care outcomes through intentional QI projects on high-priority quality concerns prevalent in the Indian scenario; and iii) Enable QI related Research and dissemination of the concept and value of methodological QI amongst the oncology community (EnQIR). A panel of editors of oncology-associated journals in India (Ind J Cancer, South Asian Journal of Cancer, Ind J Med Paed Onc, Cancer Research, Statistics, and Treatment, Ind J Surg Onc, Ind J Pall Care), pondered upon the relevance of research on Quality Improvement for our country and ways of disseminating the key concepts and the projects to their readers. The conference got approval for two KMC credits for the participants.

The conference has resulted in three groups planning actively to actualise the three themes and also invitations from oncology journals for contributing as in editorials, thematic articles and QI projects. The NCG leadership is considering upgrading the back-office support to enhance the coordination, organisational strength, visibility, and access to the completed QI projects by clear categorization of the graduation videos and access links. The first step would be to identify QI friendly NCG centres and acknowledge their contribution through a letter of appreciation from NCG for the projects completed and also by including project-summary presentations during NCG annual meetings. NCG may consider Grant support to support the future directions as in MQuIC, EnQIR, Website upscale.

NATIONAL CANCER GRID - KOITA CENTER FOR DIGITAL ONCOLOGY (NCG-KCDO)

The National Cancer Grid in collaboration with Koita Foundation has established the NCG Koita Centre for Digital Oncology (NCG-KCDO) in August 2022 with the objective of transforming cancer care in India using digital technologies. This is a major step towards fulfilling NCG's vision to deliver uniform cancer care, reduce costs of treatment, build capacity by training and education, drive cancer research and frame cancer policy across India.

The broad set of focus areas for NCG-KCDO include:

- Enabling digital health initiatives within NCG centres and across the patient journey e.g., cancer
 prevention, screening, early detection and diagnostics, in-patient care, outpatient & ancillary care,
 palliative care and survivorship.
- Supporting foundational digital health capabilities across NCG centres e.g., data management, analytics, consumer health/telemedicine and training & capacity building.



- Driving digital engagement and collaboration with ecosystem partners including government and regulatory agencies.
- The team at NCG-KCDO is being led by Dr. Nikesh R. Shah who has joined as CEO, from April 2023. Dr. Shah is a medical doctor and has spent over 20 years in healthcare consulting, operations and technology across US and India. The NCG-KCDO is building a core team of professionals with strong background in healthcare and technology to drive the conceptualization and delivery of digital health in cancer.

CURRENT INITIATIVES

NCG EMR Initiative

The NCG conducted a technology assessment survey across all NCG centres in 2022. In the survey, NCG hospitals identified Electronic Medical Record (EMR) as one of their biggest needs. Based on this feedback, NCG -KCDO have initiated the NCG EMR initiative - a first-of-its-kind initiative in India. Its primary objective is to assist NCG hospitals in selecting, deploying, and meaningfully using EMR. Successful roll-out of the NCG EMR will create a solid foundation for seamless collaboration and information exchange in cancer care with high data security and privacy standards. Most importantly, it will empower patients through ease of access of their own health records.

Key milestones achieved include:

- Oncology Specific EMR Requirements A team of experts in Oncology and Technology collaborated to create a comprehensive set of EMR requirements, encompassing over 200 essential features to align with the specific needs of NCG hospitals. - EMR Vendor Empanelment NCG-KCDO received a highly favorable response to the Request for Empanelment (RFE) and is currently in the process of empaneling EMR vendors that have a strong product and client base, and can commit NER 2.0 requirements.

Dharamshila Cancer Foundation and Research Centre, New Delhi

- Although means of diagnosing and treating early cases of cancer have improved considerably.
 Very little has been done to improve the quality of life of patients and their families, who are
 fighting with problems associated with serious life threatening diseases like cancer,
 obstructive lung diseases, end-stage failure of heart, liver and kidney, dementia, Parkinson's
 disease, strokes, and disabilities. All these patients need relief from pain and other distressing
 physical, emotional, psychosocial and spiritual problem. This is possible by providing
 Dedicated Palliative Care.
- Palliative care is specialized medical care to relieve, suffering and improve quality of life of
 these patients so that they can lead a symptom free, comfortable and dignified life from years
 to decades. About 60 lakh patients in India require palliative care, but it is available to only 2%
 of patients.
- The fulfill the gap between need and availability, Dharamshila Cancer Foundation and Research Centre Centre has commissioned Dharamshila Rahat Medical Centre in June 2022.

This is North India's first standalone, multidisciplinary, holistic, supportive and palliative care centre located in East Delhi. This is a 37 bedded facility managed by a multidisciplinary team.
