Selection Criteria	Selection will be based on the evaluation of performance of MCQ exam physically conducted at TMH, followed by VIVA on the same day. A fixed number of candidates (not exceeding 3 times the number of seats) will be called for the interview.		
Remuneration	Rs. 84000/- p.m. (fixed)		

#### **GENERAL CONDITIONS:**

1. **Last date for online application is 02.06.2026 up to 05:00 p.m. (Indian Standard Time).**
2. Candidates must send in their candidature through the "Online Application" only. **Hardcopy in any form will not be entertained.**
3. Candidates will be initially screened and called for an interview based on information provided by them in the online application form.
4. Incomplete applications will be summarily rejected.
5. Candidates who would be called for Interview are required to **carry online application form, original documents (Resume, Educational Qualification, Experience Certificate, Date of Birth Proof, Aadhar Card, Pan Card, MMC Registration) along with one set of copy** in support of the details furnished in the online application form regarding date of birth, qualifications, experience, caste, disability certificate etc., failing which such applicants will not be allowed to appear for Interview.
6. If number of Applications is more, candidates may have to appear for a multiple-choice exam prior to the Interview.
7. Tata Memorial Centre reserves the right to restrict the number of candidates called for the Interview to a reasonable limit, on the basis of qualifications and experience of the

- applicants. Mere fulfilling the prescribed qualifications will not entitle an applicant to be called for Interview.

In case it is found at any stage of recruitment that the candidate does not fulfill the eligibility criteria and/or, the candidate has furnished any incorrect/false / incomplete information or has suppressed any material fact (s), his / her candidature will be cancelled. If any shortcoming is detected, even after appointment, the services of the candidate are liable to be terminated forthwith.
