- i. **Past Employment:** Experience certificate indicating the date of joining and relieving.
- ii. **Current Employment:** Appointment letter and last pay slip.
- iii. **Copy of:** PAN Card and Aadhar Card

- 5) The above posts are for the tenure of one year from the date of appointment. The appointment is purely temporary one and it can be terminated at any time without giving any notice.
