The candidates shall make an online payment of Rs.1000/- as application fee on or before 15.05.2026. No other mode of payment will be accepted. SC / ST and physically handicapped have to pay Rs.300/- by using Debit/Credit card only. Fees once paid will not be refunded under any circumstances. Candidate shall verify their eligibility for the post before applying and making payment of application fee.

For applying Online, the applicant must possess valid email ID. All correspondence with the applicant will be done through registered email only. Selected Candidates name will be displayed on TMC website. Information regarding offer letters etc. will be provided through email. Tata Memorial Centre will not be responsible for any loss of email sent, due to invalid/wrong email ID provided by the candidate or delivery of emails to spam/bulk mail folder etc.
