Course Name	“ONE MONTH CERTIFICATE COURSE FOR LONG TERM CENTRAL VENOUS ACCESS DEVICES (CVAD)” AT TATA MEMORIAL HOSPITAL. The Department of Nursing and Department of Medical Oncology of Tata Memorial Hospital with SNDT University, (Continuing Adult Education Department) are happy to announce the Commencement of ‘One month certificate Course in Long Term Central Venous Access Devices (CVAD)’. Chemotherapy is one of the most important modalities of cancer treatment of hematological malignancies and solid-tumors. Central Venous Access Device is a safe and effective route for patients who require long duration of venous access. Oncology nurses need to develop high degree of skills in inserting, maintaining and managing the CVAD to provide comprehensive care to patients. Preference will be given to sponsored candidates.
Eligibility	Diploma in General Nursing & Midwifery/ B.Sc. Nursing or equivalent, Examination and should be eligible to register with the Maharashtra Nursing Council, proficient in reading, writing and speaking in English.
Experience	Experience of nursing in an Clinical Oncology Nursing for one year preferable.

Ten Thousand only) + 18% GST Admission Fee : Rs. 400/- (Rs. Four Hundred only) Examination Fee : Rs. 575/- (Rs. Five Hundred Seventy Five only)
Age limit	Upto 40 years (as on 18.09.2026) Relaxable by 5years for SC/ST, 3 years for OBC & 10 years for Physically Handicapped.
Duration	01 month from 05.10.2026 to 05.11.2026
Number of seats	10 (Ten)
Selection Criteria	Selection will be based on the evaluation of performance in the interview. A fixed candidates (not exceeding 3 times the number of seats) will be called for the interview.
Accommodation	All the outstation candidates are required to make a note that Hostel accommodation will be provided subject to the availability of accommodation.
Cafeteria and Library facility	Cafeteria services available as per the package opted for. In addition to actual charges refundable deposit of Rs. 5000/- for diet. A Sum of Rs. 1000/- p.m. will be charged towards transportation.

Hepatitis B 02 doses should be completed.

General & OBC candidates have to pay the Online Registration Fees Rs.1000/- & SC / ST / Physical Handicapped have to pay Rs.300/- by using Debit Card/Credit Card only. Fees once paid will not be refunded under any circumstances. Candidate shall verify their eligibility for the post before applying and making payment of application fee. Last date of online application is **18.09.2026** up to 05.00 p.m.

HOW TO APPLY: Eligible applicants would be required to apply **ONLINE** through the link on our website viz. https://tmc.gov.in/training/frm_Registration.aspx No other mode of application will be accepted.

For applying Online, the applicant must possess valid email ID. All correspondence with the applicant will be done through registered email only. Information regarding offer letters etc. will be provided through email. Tata Memorial Centre will not be responsible for any loss of email sent, due to invalid/wrong email ID provided by the candidate or delivery of emails to spam/bulk mail folder etc.

During the period of training, the Trainee shall not apply for any post or any other courses/ P.G. studies / Scholarship or appear for any examination or interview outside.

Any trainee leaving or remaining absent from the training before completion of this course will have to refund the amount of stipend together with interest thereon as per the rates, as may be fixed by the hospital.
