The above Candidates are requested to appear for exam (followed by VIVA) with all original certificates regarding qualifications, age, experience, **MCI recognition** & **NOC** from present employer etc., with **Photo ID proof** on the above date and time (half an hour before scheduled time) for exam.

1. No Traveling allowance is admissible for attending the Test/Viva. The date fixed for Test / Viva cannot be postponed. Canvassing in any form will be a disqualification.
2. **a)** The SR post is of 1 year duration commencing from **1st August, 2015**. Selected candidates has to deposit an amount of **Rs.60,000/-** at the time of joining or the same will be deducted in **Six** equal installments from their salary. The deposit will be refunded without interest on the completion of minimum six months term or after completion of Senior Resident training / term whichever is later. However, Resident can leave the post after completing six months term with one month's notice and in such case the deposit will be refunded. If Resident leave the post midway, without notice his/her last month's pay (30 days) will be forfeited.

b)The H.B.N.I. Fellowship is of 2 years duration commencing from **1st August, 2015**. The fellow will have to pay the fees and dues to HBNI as per existing rules.
3. Director (Academics), TMC is the appointing authority, whose decision shall be abiding and final.
