Offer must be submitted in the prescribed form and under sealed envelopes super scribing Enquiry no. and "Tender for the Disposal of of Hydroclave System kept in the Waste Management Division.TMH on 'AS IS WHERE IS BASIS" and addressed to the Engineer 'E' (Civil), Maintenance and Verification Cell, Tata Memorial Hospital, Dr. E. Borges Marg, Parel, Mumbai- 400 012 so as to reach him on or before 17/07/2015 up to 02.30 PM. Tenders will be opened at 3.00 PM on same day. Tenderers can attend at the time of Opening of Tenders, if they desire so.

1. **Tenders documents will be issued on receipt of payment of Rs. 500/- (non refundable).**
2. Offer must be accompanied by **Earnest Money Deposit of Rs. 1,000/- (Rupees One Thousand only)**. E.M.D. to be paid in cash (**A/c No. 439**) or by Demand Draft drawn in favour of 'Accounts Officer, TMH' payable in Mumbai only. **Offer received without original receipt of E.M.D. will be rejected. Complete address should be mentioned on back side of the receipt.**
3. Refund of E.M.D. of unsuccessful Tenderers will be made by Crossed Cheque only on submission of original stamp receipt issued by us.

In the event of acceptance of the offer, the successful Bidder will have to make payment by Cash or by Demand Draft drawn in favour of 'Accounts Officer, TMH' payable in Mumbai and arrange to shift all the items mentioned in the schedule of quantities to a common place allotted in TMH. The next day the bidder will have to collect the above items lying at TMH premises at his own expenses between 9.30 am to 4.00 pm except Saturday, Sunday, Holiday.
5. Government Levis/Taxes, VAT if any must be borne by the Tenderers.
6. Successful Tenderer will have to lift the items within four days from receiving the acceptance letter of the price offered against payment. In the event of failure to lift the items; the amount deposited by the Tenderer will stand forfeited.
