The above Candidates are requested to appear for Written test (followed by VIVA) with all original certificates regarding qualifications, age, experience, **MCI recognition** & NOC from present employer etc., with **Photo ID proof** on the above date and time (half an hour before scheduled time) for exam.

1. Weightage is given to candidates possessing prior experience in respective specialty & presentation / publications. Credits will be added to the viva total.
2. No Traveling allowance is admissible for attending the Test/Viva. The date fixed for Test / Viva cannot be postponed. Canvassing in any form will be a disqualification.
3. The Fellow post is of 1 year duration commencing from **1st August, 2015**. Selected candidates has to deposit an amount of **Rs.60,000/-** at the time of joining or the same will be deducted in **Six** equal installments from their salary. The deposit will be refunded without interest on the completion of six months term with one months' notice or after completion of Senior Resident training / term whichever is later. However, Resident can leave the post after completing six months term with one month's notice and in such case the deposit will be refunded. If Resident leave the post midway, without notice his/her last month's pay (30 days) will be forfeited.
4. Director (Academics), TMC is the appointing authority, whose decision shall be abiding and final.

Important : Produce documentary evidence that your **PG degree is recognized by the MCI** at the time of Written Test /Viva Test OR at the time of Joining. In the absence of documentary evidence that your PG degree is recognized by the MCI, you will not be permitted to join the post.
